AND WHEREAS, the institution, GYANVEER INSTITUTE OF MANAGEMENT AND SCIENCE, RUN BY GYANVEER SEVA SAMITI, PLOT/ KHASARA NO.211 HALKA NO.63, PLOT NO.211 STREET NO.MANPANI, VILLAGE/TOWN/CITY/P.O. TEHSIL/TALUKA/DIST. – SAGAR - 470003, MADHYA PRADESH (WRCAPP2046) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 242nd meeting held on February 11-13, 2016 was satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. (Increase in intake) programme, such as infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
